 - To facilitate thickness of new insulation, form new raised perimeter details raising the visible highest point of the roof by approximately 205mm.
 - Removing existing fascia and soffit boards and installing new fascia and soffit in RAL 7016 to weather new perimeter detail including kerb.
 - Replacement of existing access hatch with a new thermally broken, aluminium powder coated hatch to ensure thermal continuity and colour to match new fascia and soffit.
2. Reduction of mass and scale
 - Removal of existing water tank housings and flues reducing overall mass and scale of the roof and enhancing the aesthetics from street view
3. Rainwater goods
 - Installation of new RAL 7016 gutters to improve roof's drainage and reduce water run off. Including renewal of downpipes to match new gutters and fascia arrangement in RAL 7016
4. Decoration changes to front elevation.
 - Change of colour by painting the existing white pvc-u weatherboards black to match the colour scheme of the front porch and the new eaves detail. This will create greater cohesion to the front of the property

1. The existing roof is insulated with asphalt and felt waterproof coverings which have failed and are leaking in numerous areas. 2. Various soil vent pipe penetrations through the roof with felt weatherings and upstands 3. Timber framed access hatch with felt coverings 4. Various aerial dishes fixed to flue stacks and water tank housings 5. Existing flue stacks are masonry. Water tank housings are timber framed with felt waterproof finishes and there are aerals and dishes fixed to the stacks and housings.

Proposed materials and finishes:

1. The proposed roof is to have an insulated build up and the waterproof coverings will comprise high performance bitumen capping sheets finished in charcoal grey. 2. The existing soil vent pipes will be extended with collar joints to achieve appropriate upstands above the insulated roof and will be weather with lead sheet detailing. 3. Access hatch will be renewed with thermally broken aluminium access hatch in RAL 7016 4. Flue stacks and water tank housings are to be removed. Aerials and dishes to be relocated to a freestanding support atop the new roof covering.

Existing downpipes will be renewed in aluminium RAL 7016 downpipes to match the new gutters.
