This proposal will demolish the existing which was residential and more recently used as a church, to provide 8 self contained flats. The principle of changing the use of the land and demolishing the existing building to provide self contained residential units could be supported subject to all relevant planning considerations being acceptable. The general design and layout of the proposed scheme is considered unacceptable and appears as an over development of the site, although the design could be improved as per the comments below.
