This application is being made following the refusal of the retrospective planning application (ref. HGY/2023/3324) for the ground floor side extension and external store room with 2.5m garden walls located to the front of 20 Croxford Gardens. This application proposes the retention of the side extension, removing the external storage to the front and reducing the front garden walls to 1m in height. These remedial works aim to reduce the overall impact of the development on the streetscape and make an effort to sit more comfortably within the street - becoming subordinate in scale to the original building and respecting the unity and massing of the existing terrace.
