An infill is added to the roof (between the crests of the "M-shape") and the angle of the roof slope is changed to 45° to allow the roof to be raised and provide 2.5m of head height in the new bedrooms.
Two proposed dormers on each house, are added to the side and the back of the new roof.
Re-introducing an original element of the house's design, a chimney stack at 59 Cholmeley Crescent.
