Impacts and risks

The site is highly accessible with bus routes serviced from the main road with Stops Elizabeth Road TR and TX within 100m of the site on Seven Sister Road. Access to tube and Overground services at Seven Sisters are less than 5 minutes walk to the north east with further services south from Manor House and Finsbury Park beyond. The proposed change of use does not give rise to a material increase or change in current likely traffic volumes in the vicinity and there would be no such increase in traffic due to the proposed change of use. The proposed access to the site will not be changed.

Please provide details of any contamination risks and how these will be mitigated

There are no known contamination risks. The site has been used as a commercial premises for many years over all three floors. Members of the public and employees have been accessing the two ground floor units from the main road and no contamination has been recorded nor any hazardous materials stored on site. No internal works would affect the foundations of the site. As confirmed by the previous Prior Approval granted in April last year (your ref: HGY/2022/2787) for additional residential units on the roof of this commercial building, it was considered that the site should not be considered contaminated land as described in Part 2A of the Environmental Protection Act 1990 (a). Based on the above, there are considered to be no contamination risks in relation to the building.

The application site is not within a flood risk zone 2 or 3 and no known flooding from surface water, drains or rivers has occurred on site as confirmed by the previous Prior Approval and also by the Prior Approval of the building on the opposite side of Gourley Street at 716 Seven Sisters Road which is also currently undergoing change of use to residential.

There are no known noise from commercial properties that would impact on future occupiers. There is a residential property in the building adjoining at no.724 and also opposite at no.716 and no known complaints have been made to Environmental Health. The Prior Approval granted on 14 April 2023 (your ref: HGY/2022/2787) confirmed that noise was not an issue.

The sites either side at nos 716 and 724 already contain residential uses. Opposite on Seven Sisters Road is also a wholly residential area centred around Culvert Road. The extant Prior Approval for residential units on top of this commercial building found no impact as has the recently approved Prior Approval at no.716 Seven Sisters Road also for residential uses on the property opposite the Gourley Street elevation confirming that additional residential occupiers will not be unduly affected.
