2.18 A number of key matters were discussed and the meeting, including:

- The principle of the proposed development. The Council confirmed that as the Site is located within a Locally Significant Industrial Site, the redevelopment of the Site and the intensification of the existing warehouse use to provide units within Use Classes E(g)(ii), E(g)(iii), B2 and B8 with ancillary office accommodation would be considered acceptable and would be supported by Policy SP8 in the Local Plan and Policies DM37 and DM38 in the Development Management Development Plan Document.
- The design of the proposed development. The Council considered that the design and layout of the proposed development were considered appropriate, subject to considering the impact of the development on the neighbouring residential uses and considering the potential redevelopment of the Selby Centre (if progressed).
- Impact of neighbouring amenity. The Council advised that any boundary treatments or soft landscape measures should help to reduce the visual impact of the proposed redevelopment from neighbouring residential properties.
- Transport and highways matters. The Council advised that details on how the Site will be accessed by all modes of transport should form part of the planning application and that a trip generation/ distribution exercise should be undertaken as part of a Transport Assessment. The Council also confirmed that the Transport Assessment should assess any potential parking impacts that may arise from the development; delivery, servicing and refuse/ recycling arrangements; and sustainable and actively travel transport mitigation and improvements.
- Sustainability. The Council provided guidance on what information should be submitted in support of the planning application in respect of sustainability and energy usage.
- CIL and Section 106 Obligations. The Council confirmed that the proposed development would be subject to Mayoral CIL.
