The amended proposal includes the removal of the existing warehouse roof, which is damaged and not fit for purpose. A new flat green roof is proposed which raises the internal height to allow for more sufficient use of the space. The north and east edges of the roof are sloped to step away from the neighbouring properties. Rooflights provide light along the length and breadth of the proposal and PV panels are included upon the roof.
