Principle of development:

"...the proposal seeks to convert the property from its existing use as two self-contained flats back into its original use as a single family dwellinghouse. Whilst it would result in the net loss of one residential unit on site, it is acknowledged that the proposal would solely be reverting the use of the property back into its original use as a single family dwellinghouse. Furthermore, it would not conflict with policy DM10, as there would be no net loss of residential floorspace. As such, the principle of development is acceptable."

Design, character and heritage:

- Single storey rear extension:

"Whilst the proposed extension in conjunction with the existing ground floor additions would result in a sizeable addition at ground floor level, it would not unduly harm the scale and composition of the property."

- First floor infill extension:

"Given the mix of architectural forms on the rear elevations of properties within this part of the street and wider locality, the infill rear extension would not result in unacceptable harm to the character and appearance of the host building or the Muswell Hill Conservation Area."

- External insulation to rear elevation:

"The proposed external insulation is shown on the elevations to be proposed as a render finish. Whilst the existing external rear face of the building is brick clad, it is acknowledged that there are a number of properties nearby within the terrace and wider group of buildings that have since been clad with light-coloured render. As the external render would be isolated to the rear of the building, taking into consideration the number of other properties that have been subject to similar alterations, as long as the render is a light or white colour, the application of render would be acceptable in design terms and would preserve the character and appearance of the Muswell Hill CA."

- Window/door replacements to front elevation and rooflights:

"The replacement windows would be required to be timber framed casement units that seek to replicate the design, dimensions, opening arrangement and timber external glazing bar treatment of the existing units."

"Given the prevailing character of the street, the installation of 3 front rooflights is acceptable subject to them being conservation-style."

- Amenity:

"Due to the staggered rear building line, with the original rear building line of no. 39 projecting approximately 2.3 metres beyond the host building at first floor level, the infill of the first floor as proposed would not result in the loss of light or outlook by any neighbouring property. The height, massing and scale of the extension would not result in an unacceptable loss of light, outlook, or result in any visually overbearing impact on neighbouring properties.

Given the marginal projection resulting from the application of external wall insulation, this would not result in any material loss of light or outlook"
