Please note that pre- application advice was sought in 2021, following this advice, the design has been updated numerous times therefore all of the points raised within the original pre-application report are considered to have been addressed in this current scheme.

Original Pre-App Advice:

The proposed development would be providing additional housing which is supported. The proposal would be subject to Policy DM7 regarding infill / backland development. The site is located within the Family Housing Protection Zone (DM16) but the loss of the existing building would not result in the loss of a family sized unit.

Part B of Policy DM7 highlights 7 sub-points amongst which any proposal must relate sensitively to the surrounding area as well as the established street scene, provide a site specific and creative response to the built and natural features of the area and safeguard privacy, and amenity. As explained in more detail below, the proposal is not considered to comply with the aforementioned policy in its current form. The built form and overall footprint, including the hard

surfacing would need to be reduced significantly. The existing building is not listed, but located within the Bowes Park Conservation Area. The existing building reads as a single storey, subordinate back land building in relation to the larger buildings facing the street. This is a common feature of this part of the conservation area. Any proposed scheme would need to respect and reinforce the established townscape and qualities of the conservation area. The proposed building is modest in scale with the larger blocks of flats that traditionally face the street. The proportions, spaces and relationships between buildings had previously been considered to be compromised by the proposed layout which has now been addressed. There is no strong mandate to duplicate the design of Orchard Court. A more bespoke/contemporary design showing the rationale behind the design response would be a more appropriate way forward. Contextual drawings, views from the street would be helpful to show how any potential proposal would respond to the characteristics of this part of the Bowes Park Conservation Area. The proposed development would be accessed via a narrow and unwelcoming alleyway and would not represent high quality, safe or inclusive design. It is noted that this is an existing scenario for the existing unit, but improvements to this access should be explored. A daylight / sunlight assessment should be provided to show that the proposal would not result in adverse impacts to neighbouring residential habitable room windows. The application site is located directly south of properties with rear facing windows along Clarence Road that could be affected. The proposed building to the rear of Orchard Court would appear visually oppressive given its scale and proximity. In addition, the inclusion of directly facing habitable room windows to the existing building (around 10m) would result
