Conditions: (4)

- 1 The development under consideration shall be for a limited period expiring on 31st October 2024.

Reason: This condition is imposed by virtue of Section 91 of the Town and Country Planning Act 1990 and to prevent the accumulation of unimplemented planning permissions.

- 2 The development hereby permitted shall be retained in accordance with the approved plans and drawings listed in this decision notice, other than where those details are altered pursuant to the conditions of this planning permission.

Reason: For the avoidance of doubt and in the interests of proper planning.

- 3 This permission shall be for a period, not exceeding the date of 31st October 2024. The use hereby permitted shall be discontinued and the land restored to its previous condition on or before the 31st November 2024.

Reason: In the interest of the preservation of local sport provision and neighbouring amenity.

- 4 The development hereby permitted shall not at any time be floodlit or benefit from any other illumination.

Reason: In the interest of neighbouring amenity.
