Deconversion / Amalgamation Policy Guidelines

Dear Robert ,

The amalgamation of the flats back into one family dwelling does not require planning permission. Planning permission is only necessary when the number of units is increased, but is not necessary when it is decreased.

The amalgamation/deconversion requiring planning permission depends mostly on the policies and strategic plans that a borough has in place. In the case of Haringey, the Local Plan is not reliant on conversions to meet its strategic housing target as well as there are no current policies that oppose such works. As such currently the amalgamation/deconversion in Haringey is seen as not requiring a planning permission. While the amalgamation itself does not require planning permission, external works related to it might require planning permission. If you are unsure whether something needs planning permission, you can always contact us again for those alterations. As the property is being converted to a single dwellinghouse, it will regain its permitted development rights and as such works which will be possible under permitted development rights can be carried out as part of the deconversion.

Dear Rob,

Apologies for not getting back to you earlier.

-Regarding the rear extension:

You will need to complete the deconversion before you can apply for the prior approval. This is because the property will still be considered flats at time of submission, and this will result in a refusal, as flats do not benefit from this type of works under PD.

-Regarding the amalgamation:

Unfortunately, it is a bit of an awkward timing. Since our initial correspondence, the council has been looking into restricting some of the amalgamations due to pressure to deliver more housing. The policies will be changing from 'loss of residential floor space' to also include 'net loss of residential units'. Some areas will be affected more than others, as we are also trying to boost family sized units in certain areas of the borough.

Given those upcoming changes, the best way forward will be to submit planning application for amalgamation as soon as possible. This way the application will still be fine on principle of proposal, and get an easy approval. After which and can take your time with completing the works at your pace. Additionally, it will also give you all the necessary proof to alter the street numbering, council tax, etc. It will allow you to build the small extension right away, as well as apply for the prior approval much earlier, as having approved planning application for the deconversion means that you can apply for prior approval for large home extension the moment the internal division (internal entrance doors) of the flats is gone.
