"Dear Roland,

We have recently received a note of refusal of the application HGY/2024/2030. The full report about the recommendations is attached below.

We tried contacting Haringey with some queries but haven't heard back hence writing to you.

We studied the report in detail and we need to point out that only the tri-partite window on the principal front facade dates from late 19th Century. The other two single sash windows date from late 20th Century as evidenced by the drawing attached below.

We were quite surprised not to be contacted again following the request for further site photographs back in early September and asked to amend the application as there was no objection to the replacement patio doors and decking. We are also surprised that the Council's own records, such as the drawing attached below have not been considered regarding the history of windows, in particular the single sash windows on the building. It is clear the two belonging to our clients do not date from the 19th century given the date of the document is year 2000.

Our Clients, who have already experienced problems with the patio door, are worried the existing rotten frame could cause further damage to the listed fabric which they want to avoid. They also want to ensure that the wrong decision is not made a precedent for further cases when care of listed building is concerned.

Could you please get back to us so we can jointly prevent an error?"

I can confirm that the heritage officer was happy with the replacement balcony door and decking. Therefore, if you wished to re-apply for this aspect of the proposal as outlined in previous submission, I don't envisage there being any resistance to being granted planning permission/listed building consent."
