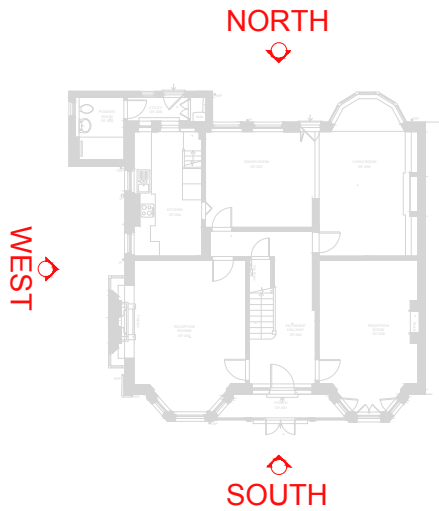




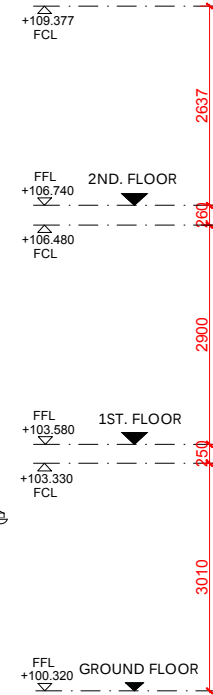
01 NORTH ELEVATION- PROPOSED

GENERAL NOTES

- PROPOSED NEW FRONT ENTRANCE PORCH. REFER TO DRAWING A301 AND A601.
- PROPOSED NEW REAR BAY WINDOW IN THE KITCHEN. REFER TO DRAWING A301 AND A600.
- PROPOSED NEW OPENING WITH TIMBER FOLDING DOORS IN THE DINING AREA. REFER TO DRAWING A301 AND A600.
- REMOVAL OF THE EXISTING RENDER AND APPLY A SMOOTHER RENDER IN THE SAME LOCATION, SIMILAR TO THE ONE IN SMALL EXTENSION IN THE SIDE AND REAR (REFER DRAWINGS A900- IMAGE 4). THE COLOR AND FINISHES ARE TO BE APPROVED PRIOR TO APPLICATION.
- INTERNAL ALTERATIONS THROUGHOUT THE THREE FLOORS. REFER TO DRAWING A301, A302 AND A303.
- REPLACEMENT/RESTORATION OF ALL EXISTING WINDOWS (LIKE FOR LIKE). REFER DRAWING A803. STAINED GLASS TO BE PROTECTED AND RETAINED.
- PROPOSED NEW FRONT DOOR. REFER TO DRAWINGS A601 FOR DOOR REFERENCE.
- PROPOSED NEW FRONT AND SIDE GATES. REFER TO DRAWING A006, A800, A801.
